SPECIAL DIVIDEND RECORD DATE

Reference is made to (i) the announcement jointly published by Kerry Logistics Network Limited (the “**Company**”), the Offeror and Kerry Properties on 10 February 2021 in relation to, *inter alia*, the Partial Offer and the proposed declaration of a special dividend of HK\$7.28 per Share (the “**Proposed Special Dividend**”); (ii) the circular of the Company dated 3 May 2021 (the “**Circular**”) in relation to, *inter alia*, the Warehouses Sale Agreement and the Proposed Special Dividend; (iii) the composite document jointly published by the Company and the Offeror on 12 August 2021; and (iv) the announcements of the Company dated 17 August 2021 and 24 August 2021 (the “**Special Dividend Announcements**”) in relation to the Special Dividend. Terms defined in this announcement shall have the same meanings as referred to in the Circular.

As set out in the Special Dividend Announcements, conditional upon completion of the Warehouses Sale, the Special Dividend of HK\$7.28 per Share will be paid to the Shareholders whose names appear on the registers of members of the Company on which is the date immediately prior to the Final Closing Date of the Partial Offer (the “**Record Date**”).

As the Offers have been declared unconditional in all respects and the final timetable of the Partial Offer has been determined, the Company wishes to announce that the Record Date would fall on Wednesday, 15 September 2021 without book closure, and the Special Dividend will be paid on Tuesday, 5 October 2021. In order for a Shareholder to qualify for the Special Dividend, all transfer forms accompanied by the relevant share certificates must therefore be lodged with the Company’s Hong Kong branch share registrar, Tricor Investor Services Limited at Level 54, Hopewell Centre, 183 Queen’s Road East, Hong Kong for registration no later than 4:30 p.m. on 15 September 2021.

Save as disclosed above, all other information in relation to the payment of the Special Dividend as mentioned in the Special Dividend Announcements shall remain unchanged.

Completion of the Warehouses Sale is subject to the conditions under the Warehouses Sale Agreement being fulfilled. Accordingly, the issue of this announcement also does not in any way imply that the Warehouses Sale will be completed, and the transactions contemplated by the Warehouses Sale Agreement may or may not proceed. Shareholders and prospective investors are advised to exercise caution when dealing in the Shares.
